Statement of Liability

As well as, any and all damages resulting from the mishandling of any and all property belonging to Pacific Coast Sunrises, will be the responsibility of the clients/passengers, and as a result will be added to the sum of the final bill.

Clients/passengers are "strictly" prohibited from extending any portion of they bodies outside the vehicle, while it is in motion. Clients/passengers are also "strictly" prohibited of the same while the vehicle is not in motion, causing the distraction of any and all vehicle that may be in site of vehicle belonging to Pacific Coast Sunrises that would be in motion. Violation of this requirement will result in (1) warning from the drivers. Additional violations, will once again result in the driver invoking his/hers right to terminate/ending the charter.
